## **January 2026 AGM Minutes – A review of the 2025 Season.**

**Agenda item 1.0 - Previous AGM Minutes:-** Accepted.

**Agenda item 2.0 – Summary of Secretaries Report:-** (See Website:- About Us / Committee / Sec. Report)

**Committee** – A season with a full Committee, meetings were constructive & a pleasure to attend.

**Membership** - Full Membership similar to last season, Associates membership disappointing.

**Fishery Maintenance** – A dry season minimised maintenance & pegs were fishable all season

**Communications** – A real success story, see Secretaries Report.

**Secretary's End of Season Summary** - On reflection, looking back over the season there is much to appreciate for example, Committee meetings were constructive & a pleasure to attend. We had lots of help running the matches, fishery maintenance & water quality monitoring. We had a season where every match was a social event, a good season all round.

**Agenda item 3.0 - Treasurers Report:-**

**Full Subscriptions.** We made a loss of £47.89 essentially due to an increase in Insurance & website costs.

**Fladbury Income.** We made a loss of £88.00 due to a shortfall in Fladbury Income (Assoc. Membership & Club Bookings), this was offset by cancelling the F&F on river & pools matches (£100).

**Total Loss.** £135.89 reported although £35 was paid on the night for engraving.

**2025 Sponsorship.** Over 61% of total Income £768 paid in match sponsorship.

**Match Deposits.** 2024 deposits totally recouped in 2025, £202 paid in 2025 to be recouped in 2026.

From Matches requiring a Peg Fee we made a £7 loss after handling over £1000.

We hold £1096.91 in the Bank Account (Dec.25) plus cash in hand £78.41 (minus £35).

Various Suggestions were discussed to avoid a deficit, the Treasurer suggested a Raffle & the group agreed to raise Subscriptions to £35

**Agenda item 4.0 - Election of Officers:-**

The Current Committee indicated that they were willing to continue for a further 3 years, there was no proposals & the current committee were re-elected.

**Agenda item 5.0 – Water Quality Monitoring:-**

Andy Hammerton reported on four years of Water Quality recordings at Fladbury submitted to the Angling Trust. How he is assisting the Angling Trust & assisting ARAG with their water quality measurements on the Warwickshire Avon.

**Agenda item 6.0 - Any Other Business:-**

Brian Cole suggested paying a Peg Fee at Fladbury – After discussion he withdrew the item.

The Committee suggested raising Full Subscriptions to £35 – Accepted.

The Committee suggested paying a peg fee after booking on then not turning out – Accepted

**Agenda item 7.0 – 2026 Subscriptions & Membership Cards**

The Treasurer handed out the 2025 Club Prize Money & received Subscriptions for next season. Membership cards were distributed.
