2018 Membership

22 Full and 16 Associate members representing record membership.

Fladbury Club Match Bookings - Three bookings so far:-

The "100 AC" booked Sunday 23rd September 2018 (paid)– Subsequently cancelled due to conditions, the Society have offered a replacement date.

"The Dons" have booked Sunday 30/6/2019 (awaiting payment).

"Corks AC" have booked a date in 2020 (paid).

"Cashmores MG" are expected to re-book a date in 2019.

Have we turned the corner and all of that effort at Fladbury finally paying off?

Associate Membership Card;-

Associates members tend to join around June - July and as the current card is issued annually their membership expires after 5 or 6 months. To put this right we have decided to change the Associate card duration from annual to seasonal. Current Associate members have been issued new cards that expire March 2019, we hope this results in renewed membership. Full cards will remain Annual.

Fladbury Maintenance;-

Very poor turnout in 2018, the pegs must remain fishable all season, we have to discuss this at the AGM in AOB. Following removal of trees between pegs 10-13 we have branches in peg 13 to remove.

Venue List for 2019.

Members choice of Venue;- Based upon members choices we have booked the WP, SL, and BAA matches.

Winter League;- The order has been changed to avoid consecutive Fladbury matches.

Winter League Canal Matches;- Decided to book 2nd WL match at Stoke Works and the 3rd WL match at Alvechurch, we will get these booked ASAP, a £2 peg fee will apply on match day.

Venue swap;- We have arranged a venue swap with Droitwich AC at Twynning for the 8th Aggregate match, this is the old BAA stretch. On the bank the guys agreed to include on the venue list although a bit further away than usual. We await their Fladbury exchange date.

Pairs competition on Pools Matches in 2019;-

We decided to hold a Pairs competition over the 10 matches on pools with a £2 entrance fee starting in 2019. The Aggregate pairs will also be increased to £2 in 2019. The Match Rules have been amended.

Pools increase in 2019

We discussed raising the pools to £8 in 2019, that's £1 BP, £1 WTA and £6 pools, subject to a vote at the AGM.

Society Insurance Policy

We have considered whether the current cover is competitive. The "Angling Trust" (the voice of angling) offers free Insurance for affiliated clubs and other benefits like free legal advice etc. The insurance is specific to angling clubs and joining represents a cost saving for the Society. We will make a decision in April 2019.
